INTRODUCTION TO THE REPORTS 2018

This Annual Review provides ample evidence to show that the parish continues to show signs of growth that is both rich and stimulating. I have a sense that God is doing something new in our community, specifically at St Philip with the Mission Learning Community (MLC) and All Saints Conservation Management Plan (CMP). These missional projects will be on-going for the next two years and shall prepare the way for the future.

This is an exciting time for the church, a time when, rather than leaving something behind we embrace the past, dwell in the present and look forward to the future. Throughout the journey we shall be well supported by the Bishop and his officers; specifically, the diocesan Mission Growth Advisor, Revd Steve Coneys, the Diocesan Secretary, Julian Hills and Julie Patenaude and Joseph Elders who have considerable experience in the conservation of major churches. The deanery is also developing a new Mission Strategy for the future: Deanery Open Day Saturday 18th May at St Paul's – Will you be there?

Meetings of the PCC

The PCC secretary expresses his gratitude to the minute secretary in taking the minutes and writing them up in 2018.

The following is a very brief summary of matters discussed during 2018:

Ordinary Meeting 21st February 2018

Attendance: 10

A draft application for Heritage Lottery funding for the repair and development of All Saints' Church was discussed. It was reported that the electrical repair work from the lightning strike in 2017 was in progress. Requirements for adhering to the new GDPR regulations for data privacy were described.

Ordinary Meeting 12th April 2018

Attendance: 12

It was reported that the application document for Heritage Lottery funding discussed at the previous meeting was to be redrafted by the Restoration Trust and it was agreed that it could be considered by the PCC for approval at an Extraordinary Meeting. It was reported that the accounts for 2017 had been approved by the Independent Examiner. The PCC approved the accounts with a vote of thanks to the Treasurer. There was a discussion on the falls of plaster in All Saints' caused by the ingress of moisture. The Quinquennial Report for St. Philip's had been recently conducted and some issues with the heating at St. Philip's were reported. A general faculty for maintenance at St. Philip's was unanimously approved.

Extraordinary Meeting 17th May 2018

Attendance: 11

The draft document for applying for a grant from Heritage Lottery Funds was discussed and it was agreed

that it should be entitled "Out Future Vision". It was agreed unanimously that the proposed repair work to the roof and the provision of better toilet and kitchen facilities were necessary.

Meeting 13th June 2018

Attendance: 13

Matters discussed included the forthcoming Stewardship campaign at All Saints' and St. Philip's, continuing activities by the Restoration Trust, and recommendations from the Secretary for compliance with the new GDPR legislation

Meeting 11th September 2018

Attendance: 11

The parlous state of the parish finances were discussed in some detail. As a result of changes to the grant application process it was agreed unanimously that charitable bodies would be approached for grants to cover the staged restoration, that the architect would be approached for specifications for a three phase roof restoration and that 'High level' contactors would be approached. It was also agreed that quotes should be sought for work to provide a toilet for the disabled and to repair a crack in the wall at St. Philip's.

Meeting 31st October 2018

Attendance: 13

Fund raising ideas to boost the parish finances were discussed including a Christmas Fair, carol singing and a sponsored concert to be held in April or May 2019. It was agreed that the current Mission focus for All Saints' should be the development of the choir and the restoration of the building. It was unanimously agreed that a roofing contractor should be engaged regularly to clear the roofs of All Saints' of debris to prevent the build-up of standing water which would then makes its way into the building, It was also agreed that to deal with urgent works, a Fabric Officer be appointed for both churches, while it was also noted that the Standing Committee are legally empowered to spend up to £500 on behalf of the PCC.

In addition to these full meetings, the Standing Committee met during the year to progress business matters.

REPORT OF THE CHURCHWARDENS 2018

We would like begin by thanking everyone for their continued support to us during our year as Churchwardens.

We recognise that we are called to work together in sharing resources and gifts in our Churches, and believe every person needs to be actively participating in the joy and challenges ahead.

Generally our Churches are in a reasonable condition

At St Philip's we are planning works as prioritised by our architect in response to the Quinquennial report 2018 as follows:-

- 1.1.4. EAST END NORTH AISLE NORTH SLOPE: Needs repair where four tiles have slipped.
- 1.1.5. EASTERN SLOPE ORGAN LOFT: Broken couple of concrete tiles which need replacement.
- 1.1.10. SOUTH SLOPE OF NAVE: Concrete tiled roof with three slipped tiles.

1.4.21 APEX OF NORTH AISLE GABLE: The apex of the north aisle is in poor if not dangerous state.

All these works require substantial funding of which the PCC are aware. Grant funding is being sought.

At All Saints Church, a roofing contractor has been engaged to clear the roofs of detritus twice yearly. The beneficial effects of this has been seen immediately and in wet conditions there have been virtually no ingress of water.

In order to secure the long term future of the building, restoration of the main nave roof is required and raising the necessary funds continue.

Many people put a lot of time and effort into making our churches a welcoming place to worship and visit which is down to many members of the congregation. All Saints' Church hosted a number of concerts featuring local and foreign choirs, special services for various organisations, school events, and special services over the Christmas period, which brought many thousands of visitors through the doors.

REPORT OF ST. STEPHEN'S DEPUTY CHURCHWARDEN

Services

During 2018 we have changed our pattern of worship to meeting on the second Sunday of the month for either Café Church or a Family Eucharist. On the fourth Sunday we have chosen to visit other churches to share in their worship and experience the way other Christian Families celebrate their faith. We have visited a diverse selection of churches, from Rochester Cathedral, All Saints Staplehurst, St Martins Shepway, Holy Cross Bearsted, Bearsted Methodist Church and Larkfield Church. We have been made most welcome at all churches and have enjoyed seeing how others worship.

At our regular services our congregation help by contributing to the services in some way, by serving, reading and intercessing and helping with our Café Church activities. Our Café Church activities have included themes such as 'Frozen', Mother's Day, the Royal Wedding, a Family Sports Day, Harvest Festival and a 'Come and make' Christingle service. We continue to send flyers home to the parents of Archbishop Courtenay School children and we generally see 2 or 3 additional families each time. The feedback we receive is always positive, but the lack of regular commitment is a little disappointing.

Activities

As well as our monthly church visits, we all enjoyed a lovely day out at Bewl Water, where the sun continued to shine and we shared a picnic and fun and games together.

Future

We continue to look to the future, considering a variety of activities to bring the local community into the school to share our faith and perhaps sow some seeds. With the continuation of Godly Play and Ian's assemblies our parish continues to make a valuable contribution to the spiritual life of the school. With changes in the Senior Management of the school, and the future appointment of an executive Head Teacher from the Aquila Academy Group, under the Diocese of Canterbury, we will be looking to further increase our involvement in the school.

PCC TREASURER'S REPORT and ACCOUNTS 2018

It is disappointing to report that the PCC current account finished with a deficit of £2,166.38. During 2018 we received the fifth year of the five year Mission Grant awarded to the Parish. The term 'Mission Grant' can be misunderstood. It is a payment made by the Church Commissioners to provide finance for the employment cost of our Priest-in-Charge.

The Balance Sheet shows that at the end of 2018 our only debt was to the Diocese of Canterbury in respect of unpaid Parish Share between 2002 and 2013. At the 31st December 2018 the amount of the debt had been reduced to £159,847.88 achieved by payments made during 2018 in addition to our normal Parish Share. As can be seen our total debt at the 31st December 2018 after taking account of credit balances from the various accounts listed amounted to £114,561.07. A Legacy in favour of All Saints church in the sum of £10,321.08 from the Estate of The Late Peter Reginald Hyland greatly assisted the final balance. All of our liabilities have been paid in full with the exception of the total of past years unpaid Parish Share and the Independent Examiners fee which has yet to be received.

Our Parish was awarded a five year Mission Grant to enable us to have financial resources to grow the parish numerically and to become self-supporting financially. We must be able to show the progress we have made on both parts of the conditions set before us by those who agreed to our Mission Grant application. It can be seen that financially the target set us will still be difficult to achieve. Despite that our Priest-in-Charge and the Churchwardens are grateful to those who make donations to the PCC through our Stewardship Scheme, the 'loose plate' collections taken at services and through other fund raising opportunities.

As in past years we have lost a number of parishioners by removal from the Parish or by death. Although it is pleasing to note that we have had the pleasure of welcoming new members to our congregations we have yet to welcome them to our Stewardship Giving despite the Stewardship Renewal held during 2018.

We have the responsibility of caring for two church buildings: All Saints, a Grade 1 listed building and St. Philip's, a Victorian building dating from 1856. The PCC is aware that major expenditure is required on

both buildings. The Quinquennial Reports received from the architects appointed for each of our churches highlight the major expenditure required for both buildings. The PCC simply does not have the funds to respond. It is therefore vitally important that everyone understands the weakness of our financial position and remain ready to support whatever fund-raising initiatives the PCC propose.

From the accounts detailed in later pages the financial result from each 'worship centre' is clearly shown. However special mention must be made of St. Philip's. The deficit of £3,890.13 relates to the church, a reduction of £874.78 on the 2017 deficit figure of £4,764.91. However the building is also the home of St. Philip's Centre. The accounts for the Centre are kept separately from the Church accounts although the money shown in the Centre accounts is still PCC money. Unfortunately the Centre returned a deficit of £1,370.49 in 2018 meaning that the total deficit in 2018 for St. Philip's Church and Centre was £5,260.62. However the total credit for St. Philip's Centre carried forward to 2019 was £5,457.37. Thus looking at St. Philip's Church and St. Philip's Centre as one 'unit' the result is a credit balance of £1,567.24. In my view this credit balance is a more accurate description of financial activities at St. Philip's Church and Centre. Great efforts continue to be made to increase the use of the Centre and to ensure that the charges made for the use of the Centre are in line with the cost of providing the Centre for use by the Community.

The purpose of the various deposit accounts are as follows:-

All Saints PCC is a deposit account which can be used for payment of modest amounts that are not regarded as normal expenditure.

All Saints with St. Philip PCC Business Reserve Account is used to pay for Youth Work throughout the whole parish.

All Saints with St. Philip Organ & Choir Fund has for some years been used mainly to assist with the maintenance of St. Philip's organ.

All Saints Parochial Church Council is a deposit account for use throughout the whole parish – other than where designated to a particular cause or church building - to pay for major items of expenditure.

All Saints with St. Philip Fee Account continues to receive fees due to the PCC (for example weddings and funerals) as well as other monies that have been received but are due for payment outside of the parish.

St. Philip's Church and Centre Current and Deposit accounts are the financial result of the use of St. Philip's Centre.

All Saints and St. Philip's Journal is the name of the bank account receiving money from the sale of *Community* parish magazine.

All Saints Church Shop receives money from the sale of goods held in the church shop. The operation of the church shop is for the benefit of All Saints Restoration and Development Trust to which transfers are made from time to time.

The Balance Sheet brings together all of our various accounts showing a total credit of £45,286.81 an increase of £8,478.12 entirely due to the Legacy to All Saints mentioned earlier in this report. After deduction of the money that we owe we have finished the year with a deficit of £114,561.07

The operation of our various accounts during the year is time-consuming and so I must make mention all of those who assist me with this responsibility. Carolyn Parslow presents the accounts for St. Philip's Centre

on a regular and efficient basis. The Deputy Churchwardens at All Saints church and St. Philip's church count the 'loose plate' collections and enter the information in the Register of Services. My thanks to everyone concerned.

Having outlined some depressing news of our finances as at the 31st December 2018 I can confirm that a letter dated the 27th January 2019 from Julian Hills the Diocesan Secretary was received. The letter confirmed that the Diocesan Finance and Assets Committee of the Archbishop's Council had been greatly impressed by the fact that our Parish Share had been paid in full since 2014. The Committee also noted that since 2014 we had made efforts each year to pay off the large historic arrears. As a result the Committee agreed to write off the historic arrears of Parish Share in its entirety. Therefore the accounts for 2019 will show a nil balance for historic Parish Share.
